2. **CHAMPIONSHIP FORMAT**

- a. Host Conference: **Grossmont Conference – Gary Stathus (Steele Canyon), Dennis McClanahan (Mt. Carmel) Tournament Directors.**
- b. All schools that submit a timely, official entry form online on athletic.net are eligible to compete.
- c. There are no prelims in the CIFSDS Cross Country Championships.
- d. The 2011 San Diego CIF Cross Country Championships will be conducted in five divisions, and the October 2010 CBED enrollment figures shall determine division placement (breakdown is attached).
- e. Seven students may be entered as a Cross Country team for the Finals, and only seven may run, and only five shall be counted (except in the case of a tie breaker). Ties will be resolved by counting the sixth finisher from each team concerned. Sixth and seventh runners will displace.
- f. **CIF ENTRIES ONLINE FOR 2011** Go to athletic.net for instructions to submit entries. Team entries for 7 athletes and/or individual entries for 1-4 athletes: **ENTRY DEADLINE IS MONDAY, NOVEMBER 14, AT 12:00 P.M. (NOON).** All CIFSDS meet information will be posted on the www.sdtrackmag.com. Entry fee of **\$10.00** per athlete or **\$50.00** per team will be assessed to each school to defray costs of conducting meet. Please remit payment by November 30 (submit school PO number of school check) Failure to do so will result in disqualification from the 2012 championship. There will be no seeding meeting - all starting positions are random.
- g. Protests will be addressed by the Meet Director.

4. **IMPORTANT MEET INFORMATION**

- Attached, find a map of the 2011 San Diego CIF Championship course.
- Upon arrival, coaches **only** will be allowed to pick up packets in front of the Senior Citizens Building. Please follow instructions in packet carefully. If you have name changes for your 7 runners you will need to make changes at that time.
- Divisional results will be available for coaches approximately 30-45 minutes after their school's Divisional Race.
- Awards presentations will be held on the east side of the Senior Citizens Building.

5. **FINISH LINE TIMING, SCORING, AND RESULTS**

Team scoring and results will be done by Computer Chip timing and placing. Bib number tags and video will serve as backup systems for the chip important info on packet pickup and chip timing is written below:

- When coaches pick up their school packets the morning of the meet, they will find the athletes race bib along with the computer chips that will be used for timing and scoring the races.
- If you are changing one of your seven runners that you previously entered that will be the time you need to make changes
- Additionally, in the school packet will be instructions as to the placing of the bibs and chips on your athletes. Coaches will need to make sure that the chips and numbers are correctly placed on the runners for the races.
- To be able to run, the athlete must have both the number and chips correctly in place for the finish line.
- If an athlete/school loses their bibs/chips prior to their race beginning they need to immediately go to check in and request another set. Replacement cost for bib and chips will \$5.

5. **UNIFORM INFORMATION**

- National Federation Rules 9-6-1, 9-6-2, 9-6-4, 9-6-5, and 9-6-7 will be enforced.
